



II. Annotations to the provisional agenda

- 1. The fifteenth session of the Trade and Development Commission will be held from 28 April to 2 May 2025. The role of the commissions, as subsidiary bodies of the Trade and Development Board and as defined in paragraph 121 of the Bridgetown Covenant (TD/541/Add.2), is to consider the reports of expert meetings and the synergies between the three pillars and the work of the subprogrammes of UNCTAD, as well as to conduct policy dialogue on one or two selected issues.
- 2. The topic of the substantive agenda item is leveraging international trade rules for development. In addition, the Commission will review reports of expert meetings. Furthermore, the Commission will examine relevant activities implemented by the secretariat that have promoted and strengthened synergies among the three pillars.

Item 1 Election of officers

- 3. In accordance with rule 18 of the rules of procedure of the Main Committees of the Trade and Development Board, the Trade and Development Commission shall elect a Chair, five Vice-Chairs and a Rapporteur from among the representatives of its members, taking into account the need to ensure equitable geographical distribution. In accordance with rule 19 of the rules of procedure, the Bureau of the Commission shall consist of seven members: four members from lists A and C combined, two from list B and one from list D, referred to in the annex to General Assembly resolution 1995 (XIX), as amended.
- 4. Accordingly, following the cycle of rotation, the Bureau for the fifteenth session of the Commission will be as follows: a Chair from list A (Asia), a Rapporteur from list D, three Vice-Chairs from lists A and C combined and two Vice-Chairs from list B.

Item 6

Leveraging international trade rules for development

- 12. In recent decades, it has been observed that, under appropriate conditions, trade can be a powerful engine for economic growth and poverty reduction. As such, the multilateral trade framework can play a key role in advancing global development objectives. However, developing countries and particularly the least developed countries often struggle to fully leverage this framework, due to capacity constraints and resource limitations. To maximize the benefits of World Trade Organization membership, these countries should make full use of the existing flexibilities and special and differential treatment within multilateral trade agreements.
- 13. At the same time, new global developments including new trade rules and the emergence of new issues such as climate change, critical energy transition minerals, biodiversity degradation and rapid technological transformations, are reshaping the trade policy space of developing countries. To benefit from multilateral trade rules, developing counties need to strengthen their capacities to address these issues adequately. UNCTAD stands ready to support member States better leverage development benefits from the multilateral trade rules.
- 14. By fostering discussions and bridging policy gaps, UNCTAD aims to help countries better harness the development benefits of multilateral trade rules and advance a more inclusive and sustainable global trade system.
